

## Conflict of Interest Declaration

I understand that Conflict of Interest is generally any activity that is, or appears to be, opposed to the best interests of the Bocconi University and Bocconi Alumni Community. Hence I understand and agree that in carrying out my role of Leader I am asked to observe the following conduct.

- 1) I understand that I am expected to avoid situations or activities that could interfere with my unencumbered exercise of judgment in the best interests of Bocconi University.
- 2) I understand that I should act in the best interests of Bocconi University /Bocconi Alumni Community and avoiding bringing said University/Community into disrepute.
- 3) I understand that, in my quality of Leader of Bocconi Alumni Community it is essential that I shall carry out my activities in a manner that will ensure no conflict, nor any appearance of conflict, between my personal interests and those of Bocconi University: particularly I understand and I agree that in my quality of Leader of Bocconi Alumni Community and during the course of my commitment, it is essential that I shall carry out my activities in a manner that does not pursue personal interests from which a prejudice, or economic detriment for Bocconi University /Bocconi Alumni Community may arise.
- 4) I understand that during the course of the activities I shall put in place and perform clear and transparent behavior and acts about my status as a Leader, and not generate confusion or misunderstanding in third parties about my status, my role and the purposes of my commitment, also avoiding overlapping between my profession and my being a Bocconi University volunteer.  
In particular, it must be clear to third parties that I do not carry out activities personally or in my best interest, but that I act as a Bocconi University volunteer pursuing goals and interests of Bocconi Alumni Community/ Bocconi University.
- 5) I also understand and agree that in the course of my commitment I should not work, or be an ambassador or a volunteer, or professional counsellor for any Alumni Association or University other than Bocconi Alumni Community and Bocconi University.
- 6) I understand and agree that it is my responsibility to immediately disclose in writing, before participating in any activities, any potential /actual/ supervened/ also temporary/ Conflict of Interest to the Nomination Committee or to the Bocconi Alumni Community officer based in Milan, and abstain from participation in any decisions related to the conflict situation.
- 7) I understand and agree that the Nomination Committee is in charge, on its sole discretion, for the final decision about the existence of a Conflict of Interest and any consistent consequence (i.e. temporary suspension from the activities, sabbatical period of time, removal from the commitment, non-acceptance of the commitment) , being the Nomination Committee the ultimate enforcement authority with respect to the interpretation and application of this declaration and Conflict of Interest policy.

- 8) I understand and agree that, in case of non – disclosure of a conflict or non-abstention when the conflict occurs, I will be immediately removed from my role and shall immediately cease any activity.
- 9) That being stated I understand and agree to abide by all of Bocconi University's policies and procedures at all times.
